## Opening Remarks

### **Kelli Baratti:**

## Program Background

### Kelli Baratti:

OK. For background, Kelsey Griffee approached me about forming this partnership, and after presenting it to the board of directors, we moved forward. We worked on this for a year and a half before launching last year.

We have a **five-year cooperative agreement** with BLM. I'm grateful to Kelsey Griffee and Tyson Gripp for their support and expertise. I'm very proud of the communities that participated in the first year — they were our "guinea pigs" and they accomplished incredible work.

## Application Information

### Kelli Baratti:

The **application period is live now** on the Nevada Fire Chiefs Association website.

- **Deadline:** March 1st (which is a Sunday)  
→ Applications will be accepted through **Monday, March 2nd**.
- This year, the program **will not fund education/outreach projects**.  
The goal is to prioritize **hazardous fuels reduction** and treat as many acres as possible.
- Available funding increased significantly to **\$847,665**.

All required documents are posted on the website in the order you'll need them. Contact me with any questions — if I don't know the answer, Kelsey Griffee or our subject matter experts can help.

## Scoring Criteria

We provided detailed scoring information this year. Key weighted factors include:

### 1. Nexus to BLM Land (heavily weighted)

Because funding originates from BLM, projects must demonstrate a connection.  
**Nexus = typically within 2 miles** of BLM-managed land.

## 2. Cost Effectiveness

We consider:

- Cost per acre
- Method effectiveness
- Whether the treatment is the most reasonable approach for the area

## 3. Match / In-Kind Contribution

While **no match is required**, documenting any match or in-kind support strengthens the program and helps maintain flexibility in future federal guidance.

### Examples of in-kind contributions:

- Staff time
- Use of agency equipment
- Partner organizations assisting
- Cost-sharing with other agencies

### Kelsey Griffee:

BLM increasingly wants to see some form of in-kind contribution. Last year, most awardees provided match through waived indirect costs, staff time, or phased project contributions.

## Questions from the Chat

### Q1: Should education/outreach be incorporated within a fuels mitigation project?

#### Kelsey Griffee:

Not required. Avoid adding standalone education activities. Natural outreach (signage, notifying neighbors, etc.) is fine.

#### Kelli Baratti:

Agreed — share your good work with the community but focus funds on acres treated.

## Q2: How are multiple projects scored?

**Kelli Baratti:**  
Each project is scored **individually**.

**Kelsey Griffee:**  
If your community has multiple areas, let's talk one-on-one about how to structure that.

---

## Q3: Are moderate-risk communities competitive?

**Kelsey Griffee:**  
Yes. Risk maps don't tell the whole story — practitioners know where the real risks are. Don't limit yourself.

---

## Q4: Can unincorporated towns (e.g., in Nye County) apply?

**Kelli Baratti:**  
Yes — but applicants **must have a SAM.gov account**. If a VFD or town lacks one, they should partner with a county or city that has an active account.

---

## Q5: Can tribes submit a single application for multiple communities?

**Kelli Baratti:**  
Each entity with its own SAM.gov account can apply separately. One combined application is possible only if submitted under a **single** SAM.gov account holder.

---

## Q6: What issues did Cold Creek HOA encounter with SAM.gov?

**Kelli Baratti:**  
The SAM process is strict:

- Requires a verifiable physical address (P.O. boxes not allowed)
- Undergoes multi-agency review, including Department of Defense
- Requires timely responses (72 hours–1 week)

Cold Creek struggled with completing these steps, but we're exploring support options.

---

## **Q7: Can equipment be used as cost share?**

**Kelsey Griffee:**

Yes — document it clearly.

---

## **Q8: Does applying as one community vs. a valley cluster affect scoring?**

**Kelsey Griffee:**

No. Just remember the **\$75,000 cap per project**.

**Kelli Baratti:**

Also consider bookkeeping challenges across combined communities.

---

## **Q9: What if you cannot meet the BLM Nexus requirement?**

**Kelsey Griffee:**

You lose all 10 points.

For areas like Lake Tahoe (North Lake FPD), BLM nexus is difficult — SNPLMA funding may be a better option.

## **Review of Year 1 Projects**

Six projects were funded (from 15 applicants requesting nearly \$1M).

### **1. Pershing County – Roadside Fuels Reduction**

Addressing high roadside ignition rates with extensive roadside clearing.

## 2. Humboldt County – Senior & Disability Defensible Space Assistance

Helping residents unable to complete fuels mitigation.  
Also created local small-business economic opportunities.

## 3. Lincoln County – Fuel Breaks Around Pioche

Completed key linkages between existing fuel breaks and improved community safety.

## 4. Cold Creek Canyon HOA – Clark County

Approved but not yet funded due to SAM.gov issues.  
Partnership alternatives are being explored.

## 5. Sparks Fire Department – Green Waste Disposal Program

Provided disposal options for homeowners conducting defensible space work.  
Community response was overwhelming.

## 6. Central Lyon County – Multi-Partner Riparian Fuels Reduction

Collaborated with county parks, water districts, conservancy groups, and the fire district.  
Included vegetation timing strategies (e.g., white top mitigation).

## Project Flexibility

### Kelsey Griffee:

We welcome diverse project types. Not just fuel breaks — but green waste dumpsters, private parcel treatments, and more, as long as they reduce wildfire risk.

## Key Dates:

- **Applications open:** Now
- **Deadline:** March 2 (since March 1 is Sunday)
- **March:**
  - Multi-agency review
  - Scoring
  - Prioritization
  - NFCA Board approval
  - Notifications to successful applicants

## Why this timing matters:

Awardees must go before their governing board (county commission, city council, HOA board) to accept funds. This can take several weeks.

## Acceptance documentation required:

- Meeting minutes **or**
- Signed resolution confirming acceptance of funds and responsibility

---
